**IT IS ORDERED, ADJUDGED AND DECREED** that this Agreed Judgment shall be and hereby is excepted from Defendant's discharge by Sections 11 U.S.C. §§523(a)(2)(A).

**IT IS ORDERED, ADJUDGED AND DECREED** that Plaintiffs recover from Defendant, Roger Dale Fisher, the sum of \$32,649.04. The principal amount if this judgment shall not bear interest so long as the Defendant is not in default of this payments required hereinbelow. Upon default, the principal amount of the judgment shall begin to accrue interest pursuant to 28 U.S.C.



**IT IS FURTHER ORDERED** that if the Defendant shall pay to the Plaintiff, Newton, O'Connor, Turner & Ketchum, P.C., the sum of \$15,000.00, payable at the rate of \$250.00 per month for sixty (60) consecutive months without interest. The first payment shall be made on or before August 15, 2003, and each subsequent payment shall be made on the fifteenth day of each month thereafter until paid in full. Upon the payment of the sixtieth installment specified in this paragraph, the judgment granted herein shall be deemed paid in full and satisfied. The Defendant may prepay any monthly payment(s) without penalty. If the Defendant is more than 20 days past due on any monthly payment, the Plaintiffs may give written notice of default and if such default is not cured within 10 days of the notice, then the Plaintiffs may issue execution hereon on the entire judgment amount of \$32,649.04, less any payments received pursuant to this paragraph, without further notice.


