JUDGMENT

Pursuant to the agreement of Steven W. Soule', Trustee, Gary Barnes, Frisco Title Corporation and Rosa Lee Barnes as a result of the Parties personally appearing at a settlement conference conducted on March 19, 2004, the Parties stipulate and agree to Judgment as follows:

1. This is a core proceeding pursuant to 28 U.S.C. Section 157(b)(2).
2. This Court has jurisdiction of the subject matter by virtue of 28 U.S.C. Section 1334.
3. Venue is proper with this Court pursuant to 11 U.S.C. Section 1409.
4. Rosa Lee Barnes (the "Debtor") filed a voluntary petition for relief under Chapter 7 of Title 11 of the United States Code on March 27, 2003. Steven W. Soule' is the duly appointed, qualified and acting Trustee of the case proceeding.

5. On September 19, 2003, the Trustee commenced this Adversary Proceeding against Gary Barnes seeking turnover of property of the estate or avoidance of a fraudulent transfer under 11 U.S.C. Sections 542 and 548.

6. Gary Barnes and the Trustee agreed that judgment should be entered against Gary Barnes in the amount of \$15,000.00.

7. Gary Barnes and the Trustee further agreed that if Gary Barnes paid \$1,000.00 by April 19, 2004, the judgment would be paid in full.

8. A copy of the signed judgment from the settlement conference is attached as Exhibit "A".

9. Pursuant to the agreement of the Parties and the Order Approving Settlement of Controversies, entered on May 19, 2004, the Trustee assigned his Judgment against Gary Barnes to Frisco Title Corporation.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that judgment in the amount of \$15,000.00 is entered in favor of Steven W. Soule', Trustee against Gary Barnes.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that if Gary Barnes pays \$1,000.00 to Steven W. Soule', Trustee or his assigns by April 19, 2004, this judgment shall be satisfied in full.



1. BARNES CONFESS JUDGMENT FOR ~~\$1000~~ <sup>15,000</sup>
  2. If Barnes pays \$1000 on or by April ~~15~~ <sup>17<sup>th</sup></sup> 2004, the judgment will be paid in full.
  3. All payments received by Frisco from Gary Barnes will be credited against judgment against Rosa Lee Barnes.
  4. Steve Soule to assign to Frisco title judgment against Gary Barnes.
  5. If \$1000 not paid within 30 days — April ~~15~~ <sup>17<sup>th</sup></sup> 2004, entire \$15,000 judgment will be in effect.
  6. Judgment will be recorded but must be ~~kept~~ released if \$1000 paid by April 19, 2004.
  7. Agreement is subject to Bankruptcy court approval.
  8. Frisco to prepare judgment to be approved by Gary Barnes.
