

4. Plaintiffs are hereby granted an *in personam* judgment in the amount of \$1,125.00 against Defendant, Forrest W. Carpenter. Plaintiffs shall not be allowed to execute upon this judgment so long as the Defendant is not in default of the agreed repayment terms stated below.


5. This judgment shall be payable over a term five (5) months, with no interest, in equal payments of \$225.00. The first payment shall be on April 2, 2004, with subsequent payments due on May 3, 2004; June 1, 2004; July 2, 2004 and August 2, 2004. Defendant may prepay this judgment at any time without penalty.

6. Defendant shall be in default of the repayment terms if any payment due is not received by Plaintiffs or their attorney, Mark A. Craige, on or before 5:00 o'clock p.m. on the date due. In the event of a default under this paragraph, Plaintiffs shall be entitled to issue execution upon this judgment without further notice of default to the Defendant. Upon default, interest shall accrue at the rate of 7% per annum on the unpaid balance and Plaintiffs shall be entitled to recover all costs of recovery including attorneys fees incurred in collection.

7. Upon payment in full, Plaintiffs shall issue a release and satisfaction for the benefit of the Defendant.


IT IS THEREFORE ORDERED AND ADJUDGED that the Plaintiffs are hereby granted a judgment against the Defendant as set forth hereinabove.


