ORDER GRANTING DEFAULT JUDGMENT

The above-captioned matter came before the Court on September 23, 2002, pursuant to Plaintiff NESCO, Inc.'s ("NESCO") Motion for Entry of Default Judgment, praying for judgment in the amount of \$51,803.33 plus post-judgment interest accruing after September 23, 2002 at the rate set by applicable law, until paid. Plaintiff appeared through its counsel, Doerner, Saunders, Daniel & Anderson, L.L.P. Defendant Goldman & Wahlberg, Inc. failed to appear.

The Court FINDS that this Court has jurisdiction pursuant to 28 U.S.C. § 1334 as a core proceeding pursuant to 28 U.S.C. § 157.

The Court FURTHER FINDS that service was obtained on Defendant Goldman & Wahlberg, Inc. on April 19, 2002, by regular, first class United States mail, postage thereon fully pre-paid.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court that the Plaintiff's Motion for Entry of Default Judgment should be and is granted.


