DEFAULT JUDGMENT



Soulé, Chapter 7 Trustee (the "Trustee") for the above-referenced bankruptcy estate and plaintiff in the above-referenced adversary proceeding (the "Adversary Proceeding"), comes on for consideration before me, the undersigned Judge. Upon reviewing the Motion, the Certificate of Mailing and the case file herein, **THE COURT ORDERS AND FINDS AS FOLLOWS:**

1. This matter is a "core" proceeding under 28 U.S.C. § 157(b)(2) as an action brought in accordance with the provisions of 11 U.S.C. §§ 541 and 542.
2. This Court has jurisdiction over the parties and subject matter hereto under 28 U.S.C. § 1334.
3. Venue is proper under 28 U.S.C. § 1409.

4. Just and sufficient cause exists to grant the Trustee's Motion and enter judgment in his favor against Defendant Therese A. Belden aka Therese Clay Mitchell requiring the Defendant to pay \$5,000.00 immediately to the Trustee under 11 U.S.C. § 542, and to pay all future monthly payments in the amount of \$200.00 per month to the Trustee from June 20, 2003, through December 20, 2004, in the total amount of \$9,000.00 (which includes the \$5,000.00 amount).
