ORDER GRANTING TRUSTEE'S MOTION FOR DEFAULT JUDGMENT

On this 26 day of Aug., 2003, the Trustee's Motion for Default Judgment (the "Motion") filed herein by Steven W. Soulé, Chapter 7 Trustee for the above-referenced bankruptcy estate and plaintiff in the above-referenced adversary proceeding (the "Adversary Proceeding") (hereinafter, the "Trustee"), comes on for consideration before me, the undersigned Judge. Upon reviewing the Motion and the case file herein, **THE COURT ORDERS AND FINDS AS FOLLOWS:**

1. This matter is a "core" proceeding pursuant to 28 U.S.C. § 157(b)(2) as an action brought in accordance with the provisions of 11 U.S.C. §§ 547 and 550.
2. This Court has jurisdiction over the parties and subject matter hereto pursuant to 28 U.S.C. § 1334.
3. Venue is proper pursuant to 28 U.S.C. § 1409.

4. Proper notice of the Trustee's Motion has been given and no objections have been filed.

5. The Trustee is entitled to entry of judgment on the Complaint pursuant to Fed. R. Bankr. P. 7055 and Fed. R. Civ. P. 55(b)(1).

6. The Trustee is entitled to a judgment pursuant to 11 U.S.C. § 542 for an accounting and turnover of any money and/or property of the estate held by Defendant N&R Services.

7. Within ninety (90) days the Petition Date, Defendant N&R Services received certain payments from the Debtor totaling \$22,330.00. The Trustee is entitled to a judgment pursuant to 11 U.S.C. § 547 adjudging said payments to be preferential transfers.

8. The Trustee is entitled to a judgment against and an order requiring Defendant N&R Services to pay \$22,330.00 to the Trustee pursuant to 11 U.S.C. § 550.
