**DEFAULT JUDGMENT**

Upon consideration of the "Motion for Default Judgment" filed by Plaintiff American Direct Mail Partners, Inc., debtor in possession ("Debtor"), the Court, having reviewed the file and pleadings, and otherwise being fully informed in the premises, hereby makes the following findings and conclusions which constitute its decision and judgment in this proceeding:

1. The Court finds that this is an action for turnover of property pursuant to 11 U.S.C. §542. The Court further finds that Defendant AmeriComm was served with Debtor's Complaint, as shown by the Return of Service on file herein. The Court further finds that despite proper service, AmeriComm failed to file an answer in this proceeding.



2. The Court further finds that at the commencement of Debtor's bankruptcy case, AmeriComm held a deposit from Debtor in an amount of no less than \$10,273.17.

3. The Court further finds that the funds held by AmeriComm are property of Debtor and that Debtor is entitled to a judgment against AmeriComm for turnover of the amount of \$10,273.17.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Debtor have and recover judgment against AmeriComm for turnover of property of the Debtor in the amount of \$10,273.17.
