
The Court FINDS that the Defendant, Guy W. Williams, has agreed to pay, and the Plaintiff, Tulsa Postal Federal Credit Union, has agreed to accept, in full settlement, the sum of ONE THOUSAND DOLLARS (\$1,000.00), with ten percent (10%) interest thereon, payable in monthly installments of \$46.14 each, the first such payment to be due thirty (30) days from the date of the filing of this judgment, each side to bear their own attorney fees and costs.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court that the Plaintiff, Tulsa Postal Federal Credit Union, have judgment against the Defendant, Guy W. Williams, in the amount of ONE THOUSAND DOLLARS (\$1,000.00), plus interest at the rate of ten percent (10%) per annum, and that said judgment shall be payable in monthly installments of \$46.14 each, the first such installment being due thirty (30) days from the date of the filing of this judgment.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court that this judgment is an exception to the discharge of the Defendant in Case No. 97-0521-R, and that each side shall bear their own attorney fees and costs.
