ORDER AND ENTRY OF DEFAULT JUDGMENT
AS TO FORD MOTOR CREDIT COMPANY

This matter comes on before this Court on this ____ day of _____, 1998, the Plaintiffs/Debtors, John Henry Donald Chaney, Jr., and Tawanna Dawn Chaney, having filed a Complaint to determine the dischargeability of the Debts and to avoid lien of the Defendant, Ford Motor Credit Company, and the Defendant Ford Motor Credit being in default, the complaint of the Debtor's is taken as true and the Court would find and Order as follows, to wit:

1. That the Plaintiffs/Debtors, John Henry Donald Chaney, Jr. and Tawanna Dawn Chaney are Debtors and that the Ford Motor Credit Company is a Creditor in the Debtors' Bankruptcy case number 97-04894-R. That the Ford Motor Credit Company did obtain judgment in the Civil Court in Case Number C-89-339, in the County of Washington, State of Oklahoma, in the amount of \$3,295.80, together with interest


thereon, on the 3rd day of July, 1989. That the Judgment of this Debtor is dischargeable in the Debtors Bankruptcy case.

2. That Ford Motor Credit Company did file an Affidavit of Judgment in Case Number C-89-339, on the 12th day of July, 1989, which was recorded under number JL-89-103, which made this Judgment a lien against the Debtors' homestead as described below. That the lien should both be avoided pursuant to the Bankruptcy Code as to the homestead of the Debtors.

4. That the homestead of the Debtors is described as:

The N/2 of the SW/4 of the SE/4 and the NW/4 of the SE/4 of the SE/4 in Section 28, Township 28 North, Range 13 East, Washington County, Oklahoma.

5. That the Ford Motor Credit Company is hereby directed to release its Judgment Lien as to the Debtors' homestead above referenced and a copy of this Journal Entry of Judgment may be recorded in the Washington County Clerk's Office in Washington County, State of Oklahoma, to release the said Judgment if Ford Motor Credit Company fails to do so.
