


corporation ("USA Funds"), recover judgment of the Plaintiff, Mark Colin DeWitt, in the sum of Six Thousand and No/100 Dollars (\$6,000.00), without interest thereon, and that said sums are determined to be non-dischargeable pursuant to § 523(a)(8)(B).

Execution on this judgment shall be stayed as long as the Plaintiff commences installment payments on or before the last day of September, 1997, in the amount of \$50.00, and maintains like installments to be due and paid on or before the last day of each succeeding month thereafter, each in the amount of \$50.00 per month, until paid in full, which should extend over a period of approximately one hundred twenty (120) months, or, ten (10) years, **PROVIDED, HOWEVER**, in the event of default in any timely payment called for by this Order and resulting judgment, the entire balance shall immediately become due and payable without further notice to the Plaintiff, for all of which, let execution immediately thereafter issue.
