JUDGMENT

This Adversary Proceeding came before me, the Honorable Dana L. Rasure, United States Bankruptcy Judge, and the issues being duly heard and a decision having been duly rendered:

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the Complaint of Kimberly Diane Alexander, now Cole, should be granted, and that Kimberly Diane Alexander, now Cole shall be awarded judgment against David Michael Alexander in the sum of Seven Thousand Seven Hundred Seventy Three and 00/100 Dollars (\$7,773.00), with simple interest to accrue daily at a fixed rate of seven and one-half percent per annum (7.5%) from April 15, 1998, and that said sums are determined to be non-dischargeable pursuant to 11 U.S.C. Section 523(a)(5).

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that execution of this judgment shall be stayed as long as David Michael Alexander commences installment payments on or before May 1, 1998, in amounts to be amortized by Kimberly Diane Alexander, now Cole, over a period of seventy-two (72) months, but which will approximate the sum of \$134.40 per month, with like installments to be due on or before the first day of each succeeding month thereafter until all principal and accrued interest is paid in full.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that David Michael Alexander may pay this judgment at any time without pre-payment penalty.


IT IS FURTHER ORDERED, ADJUDGED AND DECREED that in the event David Michael Alexander fails to make any monthly payment to Kimberly Diane Alexander, now Cole, within ten (10) days of the first of the month, the entire balance of Fifteen Thousand Five Hundred Forty Six and 00/100 Dollars (\$15,546.00) shall immediately become due and payable, minus payments previously made, without further notice to David Michael Alexander, and that said sums are determined to be non-dischargeable pursuant to 11 U.S.C. Section 523(a)(5), for all of which let execution immediately thereafter issue

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that each party shall bear their own costs and attorney fees incurred in this Adversary Proceeding.


