IT IS ORDERED AND ADJUDGED that the Defendant, Oklahoma State Regents for Higher Education, recover of the Plaintiff, Brenda Kay Harris, judgment in the total sum of \$2,500.00, without the accrual of interest.



IT IS FURTHER ORDERED AND ADJUDGED that execution on this judgment shall be stayed as long as the Plaintiff commences installment payments on or before the 10th day of May, 1999, in the amount of \$50.00 per month, with like installments to be due on or before the 10th day of each succeeding month thereafter until the judgment and accrued interest are paid in full, **PROVIDED, HOWEVER**, in the event of default in any timely payment called for by this Order and resulting judgment, the entire balance shall immediately become due and payable without further notice to the Plaintiff, for all of which, let execution immediately thereafter issue.


