
JOURNAL ENTRY OF JUDGMENT


This matter comes on for consideration upon Plaintiff's Complaint to Determine Dischargeability of Debt. Plaintiff appears by and through its attorney of record, Roger D. Everett. Defendants, Johnny R. Murray and Patricia S. Murray appear by and through their attorney of record, F. Eugene Hough. The parties announce to the court that an agreement has been reached in that Plaintiff shall be entitled to a judgement in the sum of Two Thousand Dollars (\$2,000.00) against the Defendants, with said debt to be non-dischargeable. That further the parties have agreed that the Defendants shall make monthly payments in the amount of Eighty-Three Dollars and thirty-three cents (\$83.33) a period of no longer than twenty-four (24) months or until said judgment is paid in full.


The parties further agree that should the Defendants fail to make the said monthly payments, then and in that event the Plaintiff shall be entitled to take all legal collection efforts and the unpaid amount of the judgment will draw interest at the rate of 15.90 percent per annum.

IT IS THEREFORE ORDERED that Plaintiff shall be granted a judgment against the Defendants in the sum of Two Thousand Dollars (\$2,000.00) and that said debt is deemed non-dischargeable and will be paid to Plaintiff in twenty-four (24) monthly installments of Eighty-Three Dollars and thirty-three cents (\$83.33).
