The parties announce to the Court that they have reached a full and complete settlement of all issues herein and request that the Court approve the following stipulated judgments:

IT IS ORDERED, ADJUDGED AND DECREED that the indebtedness due to the Plaintiff, Citibank, upon account 5424 1801 1675 9538, by the Defendant, William S Dietrich, in the amount of \$3,075.00, is determined to be non-dischargeable.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Plaintiff is granted judgment against the Defendant in the amount of \$3,075.00, without interest, provided the payments are made in conformity with this judgment, if the payments are not made in conformity with the judgment then the judgment shall accrue applicable interest from this date.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Defendant is hereby granted a stay of execution conditioned upon the payment to the Plaintiff of monthly installments in the sum of \$90.00, payable in consecutive monthly payments beginning



Should the Defendant default upon any payment by more than ten (10) days, then interest shall accrue upon the unpaid balance at the contract rate and further the Plaintiff may execute upon this judgment until the same is paid in full.




