**PARTIAL RELEASE OF JUDGMENT


property, only:

LESS that part of Lot One (1), Block Four (4), UNIVERSITY PARK, A Subdivision in Tulsa county, State of Oklahoma, according to the recorded Plat thereof, being more particularly described as follows, LESS BEGINNING at the Northwest corner of said Lot 1; thence East along the North line of said Lot 1, a distance of 30 feet; thence S 40° 00' 00" West a distance of 25.08 feet; thence S 4° 27'48" West a distance of 86.57 feet to a point on the South line of said Lot 1; thence West along said South line a distance of 4.05 feet to the Southwest corner of said Lot 1; thence North along the West line of said Lot 1 a distance of 105.40 feet to the point of BEGINNING.

NOW, THEREFORE, in consideration of payment of the sum of \$500.00, the receipt of which is hereby acknowledged, the undersigned Judgment Creditor, United Student Aid Funds, Inc., a Non-profit Delaware Corporation, does hereby partially release the aforesaid Judgment and does hereby partially release its Judgment Lien as to the property in University Park described above; reserving all other rights conferred by said Judgment.


