**AGREED JUDGMENT**

This Court, upon review of the pleadings on file in this Adversary Proceeding, and consideration of signatures of the parties below, finds as follows:

1. Donna J. Payne filed a voluntary petition for relief under Chapter 7 of Title 11 of the United States Code on July 7, 1999, listing RCB Bank as a secured creditor. RCB Bank has filed a claim in the amount of \$29,638.32.

2. RCB Bank commenced this Adversary Proceeding pursuant to 11 U.S.C. Section 523(a)(2) and (6) to determine the dischargeability of the debtor's obligations to RCB Bank. This Court has jurisdiction of the parties and the subject matter herein pursuant to 28 U.S.C. Section 1334. This is a core proceeding.

3. An Order Approving Motion to Compromise and Settle Controversy was filed on June 12, 2000.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Donna J. Payne agrees to make monthly payments of \$100.00 to RCB Bank with the first payment due 20 days after the settlement was finally approved by the Court.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that RCB Bank agrees to apply the entire payment received by Donna J. Payne to the principal amount of \$4,600.00, provided the payments are timely and in full.


