AGREED JUDGMENT

This adversary proceeding matter comes on for consideration before the Court. Plaintiff/Creditor, GENERAL ELECTRIC CAPITAL CORPORATION, herein, is represented by David O. Beal, attorney, of the firm of Love, Beal & Nixon, P.C. The Defendant(s)/Debtor(s), KAREN A. DAVENPORT and , herein are represented by Julia Draughon, attorney.

The parties, by their respective counsel, advise the Court that, this matter was filed by Creditor against Debtor(s) objecting to dischargeability of a credit card debt pursuant to §523 (a)(2)(A) and/or (C). The parties, by their respective counsel, advise the Court that, subject to the Court's approval, they have come to an agreement for judgment in this matter.

The parties advise the Court that the terms of the agreement are:

1. Judgment for Plaintiff in the sum of \$3,437.00;
2. Monthly payments in the amount of \$50.00 with the first payment to commence twenty (20) days from entry of this judgment;
3. interest will not accrue on this judgment; as long as regular payments are made; should payments not be made, the judgement will accrue 21.00%
4. Judgment to be released when paid in full;
5. Each party to bear its/their own attorney fees and costs.

The Court finds that the agreed judgment is fair and equitable and should be approved.


