This matter comes on before the undersigned pursuant to the settlement agreement between the parties dated July 25, 2001. Based upon the stipulation of counsel for the parties it is

**ORDERED, ADJUDGED AND DECREED** that judgment be, and it hereby is entered in favor of Plaintiffs against Defendants, in the amount of \$12,500.00, inclusive of interest, costs and attorneys fees, if any are allowed by law. The judgment shall bear interest at the rate prescribed by law beginning with the date of entry of this judgment. It is further

**ORDERED, ADJUDGED AND DECREED** that Plaintiff shall take no steps to collect this judgment so long as Plaintiff receives from Defendants \$50.00 per month, on or before the 17<sup>th</sup> day of each calendar month, payable to Roberta Colasurdo/Ruppel, Trustee, at 7025 S. 151<sup>st</sup> W. Ave., Sapulpa, Oklahoma 74066 beginning August 17, 2001, and continuing for a period of five (5) years, for a total of sixty (60) installments. In the event Plaintiff timely receives all 60 payments, Plaintiff shall execute and deliver to Defendants a release and satisfaction of judgment.


