**LEGAL WORK EXPERIENCE:** Legal work experience is defined as progressively responsible experience in the practice of law, in legal research, legal administration, or equivalent experience received after graduation from law school. Major or substantial legal activities while on military duty may be credited on a month-for-month basis whether before or after graduation, but not to exceed one year if before graduation from law school.

To qualify for JSP grade 12, an individual must have one year of legal work experience and be a member of the bar of a state, territory, or federal court of general jurisdiction.

COURT PREFERRED SKILLS: Prior clerkship experience; graduation from law school with a cumulative GPA of 3.5 or higher; excellent legal research, writing, and communication skills; and familiarity with the CM/ECF system, the Bankruptcy Code and the Federal Rules of Bankruptcy Procedure.

**BENEFITS:** Employees of the Federal Judiciary are entitled to federal employee benefits including health, dental, vision, and life insurance programs; paid leave; periodic grade and step increases; and paid holidays. ## **Conditions of Employment**

- Applicants must be a citizen of the United States or eligible to work in the United States.

- Employees of the United States Bankruptcy Court are excepted service appointments.
- Excepted service appointments are at will and can be terminated with or without cause by the Court.
