| (a) Transcript Production | The fees cover all costs of transcript production. |
| (b) Original Fee | For any given proceeding/date there can only be one original charge. All other transcripts of <br> the same proceeding must be at the copy rates. The original fee rate may not be charged to <br> parties who order a transcript that was already produced at the request of a judge. |
| (c) 14-Day, 7-Day, Next- <br> Day, and 2-Hour <br> Transcripts | In the case of 14-day, 7-Day, Next-Day and 2-Hour transcripts, the approved fees are to <br> cover all costs of transcript production, including payments to extra court reporters, typists, <br> and transcribers to help produce the transcript. <br> Note: 2-Hour Not offered by this Court |
| (d) Copy Fee | A copy fee is charged if the party orders and receives a copy. |
| (e) Fee for Sale of <br> Transcript on Electronic <br> Media | The rates allowed for electronic media transcripts are the same as those allowed for paper <br> transcripts whether they represent originals, first copies, or additional copies. No additional <br> charge is permitted for the cost of the electronic media. |

## Example of Fee Calculation.

A party orders an original and one copy of an ordinary transcript of 50 pages. The court reporter charges the party at a rate of $\$ 4.00$ per page for the original and $\$ 1.00$ per page for the copy. The court reporter bills the party $\$ 200.00$ for the original and $\$ 50.00$ for the copy for a total bill of $\$ 250.00$, delivering both the original and the copy to the party. The court reporter also delivers to the clerk of court (through the court reporting supervisor) a copy of the transcript for the records of the court at no charge to the party or court. Another party orders two copies of the same transcript. The court reporter charges this party at a rate of $\$ 1.00$ per page for the first copy and $\$ .70$ per page for the second copy. The court reporter bills the party $\$ 50.00$ for the first copy and $\$ 35.00$ for the second copy for a total bill of $\$ 85.00$.
